Q: When can I do my next Annual Training & Assessment?

A: It starts from the 1st May 2021. Due to the impact the MOT extension has had on MOT volumes, DVSA are recommending you get your training completed as early as possible.

Q: What is the pass mark this year?

A: It is 80% again this year & there have been lots of changes recently to the guides & manuals so we're expecting another difficult year.

Q: Can I just do the exam?

A: No, every year testers must complete 3 hours of mandatory training & pass the assessment. When DVSA visit sites, they will request to see tester training records. If a tester is unable to produce any records, sanctions will be issued.

Q: What options are there for my Annual Training & Assessment?

A: This year we have listened to feedback from testers & garage owners. It's clear that last years assessment was difficult, therefore our new packages are aimed at providing testers with the necessary confidence & skills to complete the assessment & also support businesses to continue running their day-to-day business.
